The Minutes of the Fifteenth National Conference of the Evangelical Congregational Church 2017 Campus of Messiah College Grantham, PA

First Day – Wednesday, May 24th, 2017 Morning Session

Opening The sessions of the fifteenth National Conference of the Evangelical

Congregational Church convened at Messiah College, Grantham, Pennsylvania

on Wednesday, May 24th, 2017.

Workshop A training event for first time lay delegates was held prior to the opening of the

Conference session.

Rev Run The "Bishop Kevin Memorial 5K Rev Run/Walk" event sponsored by the

Healthy Pastors Team & the Kingdom Extension Community was held to financially support church planting and promote physical activity among our

pastors and lay delegates.

First Day – Wednesday, May 24th, 2017 1:00 P.M. Communion

The Conference gathering was begun with a service of Holy Communion led by Bishop Bruce D. Hill in the Messiah College's Hostetter Chapel.

First Day – Wednesday, May 24th, 2017 Afternoon Session 2:30 P.M.

Opening Rev. Bruce D. Hill, fourteenth Bishop of the Evangelical Congregational Church,

called the business sessions of the fifteenth session of the National Conference of the Evangelical Congregational Church to order at 2:30 PM in the Eisenhower

Center of Messiah College. He opened the session with prayer.

Discipline Rev. Jeffrey G. Byerly, First Assistant Secretary, read from the *Discipline*.

Voting Rights Bishop Hill explained the voting rights to the delegates of the National

Conference.

Standing Rules On motion, the Standing Business Rules as found in the Conference Journal

and in the report packet were adopted.

Conference Roll The Secretary reported changes to the distributed Conference roll list. On

motion, the Conference roll was adopted.

Conference Boundary, in keeping with section D of the

Standing Rules, was established.

Correspondence Rev. Kirk R. Marks, National Conference Secretary, reported that one item of

correspondence was received in the form of a letter from Bishop Emeritus Michael W. Sigman addressed to the members and friends of the National

Conference. The letter was read.

Episcopal Address Conference Vice Chairman, Rev. Gary Brown, assumed the chair and Bishop

Hill presented his Episcopal Address. On motion, the address was adopted with

appreciation.

Women's Program Bishop Hill announced the women's program for this Conference session and

dismissed the participants.

The Conference session stood at recess for ten minutes.

Rev. Kirk R. Marks, National Conference Secretary, presented his report. He **NC Secretary**

noted that some versions of his report as distributed required correction in the reporting of the minutes of the March 16, 2017 NMT session. At that session, Rev. Sizemore reported that he will not be pursuing an additional term as Global Ministries Associate when his current term expires in June of 2018. Some versions of the report omitted the word "not" which significantly changed

the meaning. All official versions have been corrected.

On motion, the report was corrected and adopted.

Mrs. Debra Patterson, National Conference Treasurer, presented the treasurer's Treasurer's Report

report and the narrative portion of the Finance Committee report. **On motion**,

these reports were adopted.

Episcopacy Committee Rev. Marlin Lafferty, chair of the Episcopacy Committee, presented the

Episcopacy Committee's report, which included the results of the Bishop's

evaluation. **On motion**, the report was adopted.

Episcopal Fund An offering was taken for the Episcopal Fund. Bishop Hill announced that the

offering amounted to \$975.

Bishop Hill vacated the chair and Conference Vice Chairman, Rev. Gary Brown, Roundtable Discussion

> assumed the chair. Bishop Hill then led a roundtable discussion with the Executive Director and Associates, which helped describe the workings of the new structure. The group discussed how disciple making is being fostered in all areas of the denomination. The group also discussed the resources that the

various communities make available to local churches.

CNT The Conference Network Team members each have submitted written reports to Recommendations

the Conference and those written reports as distributed included two

recommendations for action:

1. Rev. Jeffrey Byerly, Ministerial Development Associate, presented the "Profile of an EC Pastor" document included in his written report. On motion, the document was adopted by the Conference and will be included in the appendix

section of the journal.

2. Rev. Randy Sizemore, Global Ministries Associate, provided some background on our EC Missions Conference in Mexico. He then presented the motion from GMC that this National Conference of the Evangelical Congregational Church, USA, grant National Conference status to the Evangelical Congregational Church of Latin America with all the rights and

privileges outlined for National Conferences in the Discipline, On motion, the

item was tabled.

Recognition The Conference recognized Brenda Long for 43 years of faithful service to the

EC Church in various capacities in the EC Church Center offices. Brenda will be

transitioning to part-time work in the coming year.

Stationing Committee

Rev. Richard Nahodil presented the stationing report. **On motion**, the report was adopted. Printed copies were made available to the delegates.

On motion, the session was adjourned.

First Day – Wednesday, May 24th, 2017 Evening Session 7:00 P.M.

Worship

The Conference celebrated a service of worship with the leaders from the EC Church of Mexico.

Rev. Randy Sizemore, Global Ministries Associate made the following statement:

Since 1977, with the influence of EC missionary, Mae Royer and other key leaders, the mission conference that we affectionately call the EC Church of Mexico has been preaching the Good News of Jesus Christ, baptizing and equipping believers, planting local congregations and ministering to the homes, families and communities in Northern Mexico with unconditional love, unending sacrifice and an unstoppable resolve, inviting their fellow countrymen to come follow Jesus. Overcoming numerous obstacles including poverty, violence, crime, persecution, corruption, a lack of education and resources, the leadership and members of this conference have faithfully continued to build up the Church both spiritually and physically.

Under the current leadership of Rev. Elias Martinez, and his wife Myrna, the Evangelical Congregational Church of Mexico was the first international conference to respond to my challenge of cross-pollinating the Global EC Church, not only donating funds to Liberia and Nepal but Elias traveled with me to these countries to help me help them in their struggles to become self-governing, self-supporting National conferences. Elias and his leadership have been sending their own missionary teams to the indigenous forgotten people in southern Mexico and actively reaching beyond their current borders with the Gospel. By the way, their official name is the Evangelical Church of Latin America because, as they have stated in their documentation, they believe God has called them to evangelize the Spanish speaking people in all of Latin America, not just Mexico.

In 2009 Elias was appointed the Director of the conference and challenged with the task of leading them to National Conference status by 2016. He and his leadership team which includes Juan Zuniga, accepted my challenge, embraced my coaching, and exceeded my expectations! I don't have the time to tell you how they have literally restructured, reformed and revived the pastors, pastors' families, congregations and spirit of their conference.

They submitted the required documentation to the Global Ministries Community and the National Ministry Team, proving their ability to be self-governing, self-supporting and self-propagating and have also submitted their constitution detailing a culturally appropriate structure to advance the mission of the Evangelical Congregational Church of Latin America.

On motion, the GMC recommendation was taken from the table. **On motion**, the item was approved and the Evangelical Congregational Church of Latin America was established as a national conference. Bishop Hill presented the leadership of the EC Church of Latin America with a plaque acknowledging their new status. An award for exemplary leadership was presented to Rev. Elias and Myrna Martinez.

Message Rev. Elias Martinez brought a message of encouragement and partnership.

On motion, the Conference session was adjourned. An ice cream social followed in celebration of the new Latin American Conference and in recognition of Brenda Long's retirement.
