



So how do we answer Job's question? Some just say "no", this life is your one shot, enjoy it, do what you want, as Isaiah quoted them, "Let's feast and drink

for tomorrow we die!" Some religions suggest you may live again as an animal or something, they aren't sure. Most people just say



The question of death and life troubled the women who walked to Jesus' tomb that first Easter morning. They soon

discovered tomb was open and empty. Mary Magdalene ran and found Peter and John telling them what they had discovered. The two disciples ran to the tomb went inside and found only the linen wrappings laying there but Jesus' body was gone; so Peter and John went home while Mary stayed behind near the tomb. At that point Luke tells us that she saw two angels who asked an interesting ques-

tion, "Why are you looking among the dead for someone who is alive?" Jesus was supposed to be dead, that's why everybody was coming to the



cemetery, that's where he was supposed to be, laying in a tomb. But he wasn't in the tomb. When we look at the question the angels ask, I'm sure to them it seemed like a dumb question, why would you go to a tomb to see someone who is alive? And that's exactly what Jesus was and is—alive!

Soon Mary Magdalene saw him for herself, then two followers who were walking to their home in Emmaus, then ten of the disciples, and finally Thomas. Luke writes, "During the forty days after his crucifixion, [Jesus] appeared to the apostles from time to time, and he proved to them in many ways that he was actually alive." Paul adds to the eye witness list by telling the Corinthians that Jesus "was seen by over 500 of his followers at one time."

News from Benefits Corporation

Thanks to almost everyone for completing the workers compensation forms on a timely basis. The workers compensation audit was completed and will have the invoices out to the churches by mid April. Early estimates indicate there will be an increase to the workers compensation premiums. While we have had minimal workers compensation claims the last two years, the Commonwealth of PA has adjusted their portion of the workers compensation premium upward.

Churches not included in the denominational workers compensation group policy; Ohio, Illinois and Kentucky churches, however your individual state mandates workers compensation coverage. Please confirm that all employees of the church are covered by workers compensation insurance. Per EC Benefits Corporation policy H.3.b. submit proof of workers compensation coverage by July 1 of each year. Please submit proof of your workers compensation coverage to:

The annual disability premium was due January 15 and the Benefit Corporation administrative fee is due by April 15, 2015, retirees are not subject to the administrative fee. Both of these fees are listed on the Treasurer's Guide available on the EC website (www.eccenter.com). Many have remitted the disability fee timely and a few have already submitted the administrative fee and we thank you for your diligence and hard work.

Treasurers please confirm that you are remitting your ministry fund payments on the correct monthly form. While the ministry fund rate did not change using the correct ministry fund form helps the business office keep accurate records.


