



# I Bring You Good News!

Did you ever think “if it weren’t for bad news, we wouldn’t have news at all”? Bad news is everywhere. Watch any news program, it doesn’t matter if in a network or FOX-news or CNN, the reports get more depressing by the hour: the economy is down, government is the definition of dysfunction, people are unemployed or under-employed, there are wars and rumors of wars. There used to be a time when it seemed like you could get away from all the bad news by turning on ESPN and watching a game, but the Penn State mess is in moment-by-moment coverage as I write this so that doesn’t even work today. Life is not easy, but I’m not sure life has ever been easy. Think about the people living in Israel at the time of the opening verses of the gospels: the Jews were living in their own land, but always under the eye and threat of the occupying Roman Empire. One word from the Roman governor and their society would be shut down. Their leaders, the members of the Sanhedrin, didn’t seem to be able to figure out if they were po-

litical or religious leaders, and the Pharisees and Sadducees couldn’t get along with each other. For too many people, religion wasn’t much more than going to the Temple to observe a special service or holiday. Sounds familiar doesn’t it?

Into this world an angel appeared to announce “I bring you good news that will bring great joy to all people. The Savior—yes, the Messiah, the Lord—has been born today in Bethlehem, the city of David!” Luke 2:10-11 (NLTse) How often do we think about the



truth that the Gospel is Good News? As followers of Jesus do we interact with each other and with our neighbors in such a way that the message that we carry in our hearts brings great joy! I’m afraid that too many of us get caught up in all the doom and gloom of this world. We look and act like everyone living around us. I’m not suggesting that we ignore the

*A couple of end of the year reminders:*



Pastor Compensation Forms should be returned to David King, Benefits Administrator, along with a copy to the Conference Minister by January 15, 2012.



Annual Statistical Report due to Rev. Ken Wiest, Statistician, EC Church Center, 100 West Park Avenue, Myerstown, PA 17067 by January 25, 2012.



W-2 forms for employees (incl. pastors) and 1099-MISC forms for independent contractors are due by January 31 to the recipient and February 28 to the respective government agency or March 31 if filed electronically.

The reporting of the cost of employer provided health insurance is not mandatory for 2011 Form W-2's issued in January 2012, relief was granted in IRS Notice 2010-69. You may voluntarily report the cost of employer provided health insurance in Box 12 with code DD. **The cost of employer provided health insurance is not taxable income.**



On January 1, 2011 a 2% reduction in the employee portion of the Social Security tax went into effect until December 31, 2011. I have heard brief news reports that the reduction may be continued for a second year and possibly include a reduction in the employer portion as well but no announcement has been made. Please remember to increase the employee portion of social security back to the 6.2% on January 1, 2012. Verification of any rate change can be found in Publication 15, Circular E, Employer's Tax Guide at [www.irs.gov](http://www.irs.gov).



The rates for the active pastor health insurance plan change on January 1, 2012 with the January payment that is due December 15, 2011. The new health insurance rates are available on the website, [www.eccenter.com](http://www.eccenter.com)



There will be some minor fund changes to the EC Retirement Plan effective January 1, 2012. Under performing investment will be replaced with funds that have had a better past performance. If you are an investor in any of the funds to be replaced you will begin to receive documentation from Prudential detailing those changes. Please contact Jennifer Buehler, Wells Fargo Investment Advisors 1-800-468-8685, if you have any questions. You also have the alternative investment options within the EC Retirement Plan.

## CHILD PROTECTION POLICY

I’ve watched the news and sports reports of the alleged sexual abuse at Penn State and, I’m sure like you, my heart breaks. My heart breaks for the children and families that have been harmed in unspeakable ways. We sit in front of our televisions and watch as so many people are caught in a web of destruction. It’s hard to believe how much everything can change in a week.

There will be many lessons to be learned as this case moves forward, and one lesson we must not miss is that the protection of our children must be a priority in our churches and ministries. Starting in 2008 our National Conference’s Christian Education Committee made child protection/child abuse prevention a major focus of their work. They produced excellent material; sample policies and procedures for our con-

gregations to implement in their own setting. (Check them out on the EC website [www.eccenter.com](http://www.eccenter.com).) The goal was to have every EC Church either have or be developing a child protection policy by the end of 2009.

My question now is what have you done with that? For too many of us a policy is a well written statement that gets filed in a notebook, put on a shelf and forgotten about. One of the lessons to be learned is that our child protection policies must be kept up to date and all our new and long-time volunteers must be regularly reminded of them to ensure that the policies and procedures your church has in place are being followed. If you never did develop those policies and would like some resources please contact Church Center or your Conference Minister.
