National Conference 2013 is on the way and that means it will soon be time for pre-conference meetings. The pre-conference meetings are to give extra time to talk about what's coming up on the National Conference agenda. It is important to attend a pre-conference meeting so we have time to talk through issues of importance to us, and to help us move through the items we need to deal with during National Conference. This year, we have two significant items to talk about.

During National Conference 2012 we approved a National Conference Relations Committee's (CRC) Pastoral Reclassification Project. When we accepted that conceptual report we gave permission to the CRC to re-write the National Conference Jour-

nal Rule 800 "Ministerial Credentialing and Classifications." The CRC has completed that work and will be presenting a new Rule 800 to the National Conference for approval. I understand that for most people the Rules of Conference are not very exciting. But it is important that we understand the CRC proposal before we vote to accept it at National Conference. Prior to the pre-conference meetings pastors and lay delegates will receive an email containing an overview of the Reclassification project and the proposed new Rule 800.

Last year the National Conference also approved my Episcopal Address recommendation to "take a 'big picture' view of the various elements that affect National Conference commissions, committees, and ministries," and conduct "a comprehensive review and strategic plan of how we 'do denomination' in the future." The Futures Initiative Team was formed to do that. The Team made a presentation to the recent National Ministry Team (NMT) and while the NMT did not endorse the report, they thought it important enough to advance it on to the pre-conference meetings for additional discussion. The Futures Initiative Team information will also be emailed to all pastoral and lay delegates prior to the pre-conference meetings. It will include an overview of our current situation, a proposed Ecclesiology Statement, and the Futures Initiative Team report.


Wesley Forum 2013 on April 4 features eminent United Methodist histo-

Thanks to everyone for completing the Workers **Compensation** forms on a timely basis. The audit was recently completed and we are awaiting the annual premium notice from our insurance carrier. We anticipate having the workers compensation invoices to the churches by mid April. But we did receive a refund from the 2011 workers compensation policy which we will apply against the 2013 invoices that should mitigate the increase somewhat. Payment for the workers compensation invoices are due 30 days after receipt of the invoice.

Churches not included in the denominational workers compensation group policy (those in Ohio, Illinois and Kentucky); your individual state mandates workers compensation coverage. Please confirm that all employees of the church are covered by workers compensation insurance. Per EC Benefits
Corporation policy H.3.b,
churches not covered by
the denomination group

policy shall submit proof
of workers compensation coverage by July 1

The major provisions of the **Affordable Care Act** (ACA) will be enacted beginning January 1, 2014. Two of the most significant changes will be the health insurance exchanges and offering health insurance to full time employees defined under the ADA as averaging more than 30 hours a week or 130 hours a month. These changes will affect us with our health insurance plan renewal on October 1, 2013. The EC Benefits Board along with our health insurance broker, PowerKunkle, is working through the potential impact these changes will have to our denominational group health insurance plan. Unfortunately, guidance or the practical application of the new law is slowly being released by Washington, so many of our questions do not have answers. And most likely there will be additional legislative and legal challenges to the ACA as January 2014 approaches that may or may not change the law. What we do know is that changes are coming that will affect our group health insurance plan but how drastic those changes will be is unknown at this time.
