

#### From the Bishop

very family has Christmas traditions: we watch "White Christmas" on Christmas Eve and read Luke's account of the birth of Jesus on Christmas morning. "White Christmas" is one of Gloria's favorite movies. I think many people who don't like snow secretly hope that there's at least a little snow on Christmas morning. The world changes under a layer of snow; everything looks so clean, so pure.

Purity is a difficult concept for us; God's purity. His holiness is hard to understand because nothing in this world is truly pure. A new layer of snow looks pure but if you really study it, if you melt that snow, you discover that it carries many impurities. Hospital operating rooms and the "clean rooms" where computer components are made are certainly more pure than the outside

world, but there is no way they can be made complete pure. A.W. Tozer wrote, "We cannot grasp the true meaning of divine holiness. [Man] may fear God's power and admire his wisdom, but his holiness, he can never even imagine." Hannah exclaimed in prayer, "No one is holy like the Lord!" (1 Samuel 2:2)

Some try to describe the holiness of God as an "otherness". God is set apart fro us; He is in a class all by Himself. When God spoke to His people through the prophet Hosea He said, "I am the Holy One living among you." (Hosea 11:9) God is holy, pure and perfect; that is His character and it says everything about Him. His love is perfect, His grace is perfect, His peace is perfect, His thinking is perfect; everything about God is perfect. His actions are perfect even when we don't understand them.

Christmas reminds us of



the difficulty understanding the work of a holy God. The prophecies had been given; the anointed one of Israel would come to set the people free. But over the years the people lost hope because they could not understand the action, or lack of it, by a holy God. Then, at the right time, God sent His One and only son Jesus. The world was confounded by the actions of the perfect God. They were not looking for a poor little baby born in a stable and laid in a manger. They

#### CHRISTMAS GIFTS FOR

MISSIONARIES: This is the annual reminder for individuals and churches who wish to give monetary Christmas gifts to our EC missionaries. If the missionary serves overseas, it is better to give the monetary gift through either the GMC office or the mission agency with which the missionary serves. Cashing checks overseas always costs the recipient a lot in fees, plus your check may be altered and cashed for a much higher amount than you intended. That's if the missionary even receives the check! If the missionary is in the USA, either permanently or on furlough, then feel free to mail the card, check or gift directly to them. #### GMC Postpones MMK Rally for 2016 to Re-group:

The GMC Mission Minded Kids planning committee has noticed that over the past few years the involvement of local churches and the number of children at the GMC sponsored MMK Rallies has declined. So, we are asking, "Is it time to do something different to help our local churches engage our local children in the Great Commission?" In order to re-group and evaluate the best way to help our local churches engage our children with the Great Commission, we

have decided to postpone the 2016 MMK Rally and use this year to evaluate and decide on a direction for the future.



## Important Update on El Retiro Children's Home (Mexico)

Over the past two years I have been writing and reporting about the aggressive new government regulations being required for children's homes in Mexico and how these regulations have resulted in the closing of other children's homes and could mean the same for El Retiro. After working directly with the leadership of El Retiro to evaluate our ability to comply and sustain these regulations, it is apparent that doing so would require more staff, daily direction and funding than is reasonably sustainable. Therefore the Global Ministries Commission has decided that instead of continuing to financially support El Retiro at our current amount and "hope against hope" that somehow something would change, we will take the next two yeas to intentionally transition out of supporting the ministry of El Retiro. During the next two years we will reduce our funding by 50% each year while continuing to help the leadership conclude what has been a very successful ministry to children in Jesus' name and to discover what the next chapter may be for all those involved. Since El

Retiro is not an orphanage but a temporary boarding home for children and youth who have legal parents and/or guardians, we are comforted by the fact that there will be viable options for the children going forward. Please note that if you are currently supporting El Retiro we would request you continue to do so for the next two years so that we can help them in this important transition.



We are in **need of housing** for two of our missionary families next year. Roy & Sue Haglund will be coming to central/eastern PA for April 2-18. They are in need of a one bedroom apartment for that time. BJ & Rachel Whitaker are also coming to PA next summer, June-August. They need a 2 or (preferable) 3-bedroom house or apartment and would like to stay in the Lebanon/Lancaster County area (Southern Lebanon to northern Lancaster would be ideal). 

#### News from Benefits Corporation



#### A couple of year end reminders:

Pastor Compensation Forms should be returned to David King, Benefits Administrator, along with a copy to the Conference Minister by January 15, 2016.

Annual Statistical Report is due to Rev. Ken Wiest, Statistician, EC Church Center, 100 West Park Avenue, Myerstown, PA 17067 (or email to blong@eccenter.com) by January 22, 2015.

W-2 forms for employees (incl. pastors) and 1099-MISC forms for independent contractors are due by February 1, 2016to the recipient and February 29 to the respective government agency or March 31 if filed electronically.

Pastors are employees of the local church and should receive a W-2 with federal, state and local taxes withheld from every paycheck.

The rates for the active pastor health insurance plan will not increase on January 1, 2016.

The health insurance rates are:

Family \$1,800 Employee w/child(ren) \$1,160 Couple \$1,390 Single \$ 660

HRA reimbursements **under the active pastors Highmark Blue Shield plan** are due to PrimePay by
December 29, 2015 for covered healthcare expenses incurred by September 30, 2015. This is an HRA rule regardless of the insurance carrier. Reimbursements received after December 29 will not be paid. No exceptions.

#### **Highmark Freedom Blue Retiree Plan**

There will be a decrease in the cost of the retiree Medicare

supplemental plan, Highmark Freedom Blue, of \$14 per month to \$197 per month. There are no changes to benefits levels.

Please remember that effective with the January 2016 premium billing no payments are to be paid to the EC Church Center. All Highmark Freedom Blue premium payments are to be paid directly to Highmark. Each retiree will receive an invoice from Highmark with instructions on how to make the premium payment to Highmark.

Each retiree should have received a letter from the EC Benefits office on how much their denominational premium reimbursement is going to change on January 1. Please contact Dave King at the EC Church Center if you did not receive a letter or have any questions on the reimbursement.

The **Manna Fund** is available to help retired pastors and widows that are struggling financially or could start to struggle with the change in health insurance premium reimbursement. Please contact Dave King to request a Manna Fund application if you are in need of financial assistance. All Manna Fund applications returned are kept confidential and only a small number of EC Benefits Corporation Trustees are involved in reviewing the applications and allocating funds. The Manna Fund currently has sufficient funds to assist retired pastors and widows and multiple EC Churches have pledged additional support.


