The annual treasurer's guide and 2025 ministry fund forms are now accessible in the members' section of the EC website. Please note that the \$100 disability fee is due by **January 15, 2025**, and the EC Benefits service fee of \$125 is due by **March 15, 2025**. The service fee helps cover the costs of the annual financial audit, Directors & Officers Insurance and other operational expenses of EC Benefits Corporation, which increasingly include professional fees as employee benefits become more intricate. The pastoral compensation forms have been updated and are available on the website.

To streamline the workload for church treasurers and minimize postage costs, the National Conference and EC Benefits offer convenient online payment options. Currently, 37 EC Churches have embraced the efficiency of electronic monthly ministry fund payments. To initiate ACH transfers for your ministry fund contributions, please reach out to Kevin Henry at <u>khenry@eccenter.com</u> or 717.628.2171.

We are implementing a new online system to streamline the reporting of wages for the annual workers' compensation audit. Detailed instructions will be provided once the forms are accessible online. This new system is designed to simplify the process compared to the previous year. We strongly encourage all treasurers to submit their wage reports electronically. If your church employs multiple staff members and the online form proves too complex, please email an Excel export directly from your payroll system. We anticipate the online reporting tool will be available by late December.

- Pastoral Compensation Forms should be returned to the EC Church Center by **January 16, 2025**.
- The Annual Statistical Report is due to the EC Church Center 100 W Park Ave, Myerstown, PA 17067 by **January 25, 2025**. Electronic Reporting option will be available.
- W-2 forms for employees (including pastors) and 1099-NEC forms for independent contractors are due by January 31, 2025, to the recipient and to the respective government agency. The 1099-NEC replaced the 1099-MISC in most instances for churches; payments made during 2024 are to be filed by January 31, 2025.
- Pastors are employees of the local church and should receive a W-2 with federal, state and local taxes withheld from every paycheck.
- The rates for the active pastor health insurance plan effective on **January 1, 2025** are below.

The HRA plan year ends on December 31, 2024 and all requests for reimbursement for the January 2024 - December 2024 plan year must be received by Benecon, our HRA administrator, by March 31, 2025, ninety days after the end of the plan year. This is an HRA rule regardless of the insurance carrier. Reimbursements received after March 31 will not be paid. No exceptions.

### Highmark Freedom Blue Retiree Plan

The retiree Medicare supplemental plan, Highmark Freedom Blue, increased by \$22 per month to \$277 per person per month, effective January 1, 2025, with minor changes in coverage levels.

For a husband and wife on Freedom Blue, double the amounts above.

Numerous Medicare Advantage plans are available, some of which may not incur any cost to the participant. However, it is important to note that each plan has its own set of advantages and disadvantages, including participating providers and benefits offered. Therefore, we strongly advise retirees to carefully research any Medicare Advantage plan before making a switch. If a retiree lacks the financial resources to cover a larger portion of the Freedom Blue plan, the Manna Fund is available to provide financial assistance.

## From Decline to Revival: A Path for Church Transformation

Turning around a church that has been in decline for decades is a daunting task. Leadership, including pastors, are often discouraged and unsure of the best path toward new life. The oft-repeated statistic is that 80-85% of churches in the United States are plateaued or in decline, and the churches of our denomination are no exception. We are blessed that the Evangelical Congregational Church genuinely desires our churches to grow healthy and effective, seeing greater vitality and excitement in their ministry.

In his book, *Comeback Churches; How 300 Churches Turned Around and How Yours Can Too* (2007, B&H), Ed Stetzer speaks very directly to pastors and church leaders. He says,

"If pastors are going to lead their churches through church revitalization, a change of focus will be required. Far too many churches focus on maintenance and not vision. That means a change in calendar, strategy and plans is needed."

One of the most encouraging things that the Church Health team has seen in 2024 is that churches in our denomination are experiencing clear signs of revitalization. It is happening in small churches with aging congregations, and it is happening in both rural and urban settings. In some cases, leadership has been a bit skeptical of the possibilities, but God has been working to encourage pastors and congregations, and they have started seeing new life in their church. Congregations have begun to embrace the culture-shift that goes with intentionally making disciples and fulfilling the Great Commission, finding creative ways to reach a community which has grown increasingly distant.

The Church Health Community would genuinely appreciate the opportunity to work with your church by helping you to assess your situation and put together an actionable plan to move forward and grow. We can make resource recommendations and meet with your team. None of our pastors should feel alone. ## **Church Planting Partnerships**

Most pastors have preached sermon series on the "one another" statements in the New Testament. Depending on translation and interpretation, we know there are at least 59 "one another" phrases and, in some counts, over 100. We were never intended to walk this journey alone. As our church has walked through the book of Ephesians this fall, I was again struck with the unity God intends for his church. We are in this together.

Bishop Randy Sizemore has done such a great job reminding us of our denomination's vision statement. For most of us, the phrase "dynamic movement of God" just rolls off our tongues at this point. Further on in that statement, we are reminded that we seek to have "Healthy churches [that] will reproduce themselves by planting churches in least-reached communities. Interdependence will be the distinguishing mark of the Evangelical Congregational Church as local churches network with one another and ministries beyond the E.C. family to proclaim the Gospel to the world."

That interdependence is so vital to who we are and what God is calling us to. I love how the Red Rose District, under the leadership of Rev. Mike Sigman (Red Rose DFD), has taken this vision to heart. At a recent district meeting, the district churches agreed to collectively get behind our El Shaddai Haitian church plant in Lancaster city. Most of the churches have already agreed to contribute to the financial support of the church and are stepping up to commit themselves as regular prayer partners. Many of the churches look forward to opportunities to come along side of El Shaddai in other ways moving forward as well.

This church plant is moving forward, seeing hearts and lives changed, people coming to Christ and disciples being made. They could never accomplish this on their own, nor can any of our church planting efforts. They need you! They need EC Districts to come together to support and pray for them; they need individual churches who will connect with and covenant together as partners with our planters in helping these new churches.

We are looking forward to our Spring 2025 courses at the EC Church's ICL!

Our first course of the semester will be "The History of Evangelicalism" in which we will chart the course of evangelicalism as we know it, beginning with the Reformation and concluding with the 21st century. In this course we will look at the individuals, events and organizations that shaped the movement as well as the historical and theological developments that shape who we are today. Classes will be held on Tuesday evenings from February 4 through March 11, 2025.

Please pray for this committee as we try to help our chaplains find answers and get the resources they need. Also pray that the Lord will call additional chaplains into His service.

Last month we announced that the NAE was offering a board certification to chaplains who desire to go a different route than that the major chaplain certifying bodies. Certification is not required for military chaplains, but the Department of Veterans Affairs, many institutions and law enforcement agencies require it. The fee will be considerably less under NAE (\$200) than the other accrediting agencies. The NAE does require you to adhere to the Code of Ethics of the Association of Professional Chaplains (APC) and respond to the 34 NAE competencies, 29 of which are those of the APC.

Our final item is regarding the annual report for chaplains, particularly for those pastors who are appointed as a "chaplain" under the National Conference. All such appointed personnel are expected to file an annual Chaplain's Service Report by January 20 of each year. As Jodi Earhart wrote: "We revised the form and added it to the <u>eccenter.com</u> website. You can find it under the Member Login, under the Forms and Resources/Board of Examiners/Annual Chaplaincy Report. It is available as a PDF or online."

For some of you who are appointed as chaplains, this may be new to you. Others have had previous experience in filing this report. Non-military chaplains need only fill out Part I while military chaplains need to fill out Parts I and II. If you have any questions, contact me or a member of the Chaplaincy Committee.

Until next month, please remember the Chaplaincy Committee and the chaplains in your prayers, especially our military chaplains as they change their commander in chief in January.
