## From the Bishop

I bought a new watch last night. That's not really big news, but it reminded me that I seem to have a "thing" for watches. I think I own over a dozen different watches. I received two for Christmas gifts. Watches are a fashion statement, a colorful accessory, and sometimes actually used for telling the time. I know people who say they feel naked if they don't have a watch on. (Gloria is one of those.) She will sometimes notice that I'm not wearing a watch and ask me about it. I usually say "It doesn't matter what time it is when I'm with you." (I think that sound romantic, but it doesn't impress her too much!) I know people who never wear a watch; they just use their phone to tell what time it is.



Calendars are like watches only a different view of time. Some still use paper calendars, while others have it on their computer, smart phone, or out there on the cloud. Many of you know that I had one of those "end of life as we know it" moments when my cloud-based calendar magically disappeared; it was all gone in the blink of an eye. Fortunately, I was able to rebuild it fairly easily because I had printed it out and I share my calendar with Jodi, my Administrative Assistant, and she had most of my appointments on her paper calendar. (Thank you very much.)

Our American culture generally lives and dies by time; whether it's the clock or the calendar. We're always looking at where we're supposed to be now and what comes next; what meeting, event, or program will demand my attention. Every evening I

look at tomorrow and the rest of the week on my calendar to make sure I know what I'm doing as I run from responsibility to responsibility. We all have responsibilities; demands are made on our time, our calendars "runneth over", our watches run too fast. Occasionally in the middle of all that I think of David's perspective in Psalm 39:6, "...all our busy rushing ends in nothing." (NLT)



I suppose we all feel that way at times, but I don't think that has to be the case. I believe we can make a difference; actually scripture instructs us that God has planned good things for us to do. Later on in the same letter to the Ephesians Paul challenges us to "make the most of every opportunity". God wants his people to make a difference in the world and sometimes in order to do that we need to take our eyes off our watches and calendars to look at him and the people he brings in to our lives; divine interruptions. So as you think about the next thing you need to do join me in taking time to see what it is that God wants to accomplish in this new opportunity.

Eventually though we felt that promoting discipleship, intentional discipleship, was the best way we could serve you. While we are still open to suggestions as to how we can best do that, we are going to start by using the **EC Leader** to introduce you to how some of our EC churches are successfully discipling.

Our first snapshot comes to you from Grace EC in Kutztown and Pastor Adam Roberts who will be sharing with you their journey with the “Orange Curriculum”.

Last year Grace Church began a multi-month-long evaluation of our children’s and youth ministries where we began asking questions like: What exactly is our disciple making strategy at Grace Church producing? Are we producing the sold-out followers of Jesus as they leave our ministry and enter the world? In other words: Are we producing the kind of disciples we’re hoping to produce? Those were hard questions to ask and to answer as they forced us to come to terms with reality. We were not producing what we were hoping to produce often enough. We came to the realization that we needed a new vision and strategy and soon our new strategy was born as we discovered a book, **“Think Orange.”**

What is “orange”? Essentially, “orange” is the combining of the light of the church (yellow) and the love of the family (red)...to create the brilliance of another, orange. More specifically, orange is a strategy of combing critical influences in life to fuel faith in the next generation and by combining those critical influences, the orange strategy synchronizes efforts and shows a generation who God is. This is done far more effectively than either “red” or “yellow” could do alone.

When the church and the family partner *together*...that is, when we as the Church equip our parents with resources and prayer and when our families turn around and support the church in ministry and prayer, *together* we can raise up kids who will love Jesus Christ more than anything else in this world...and CHANGE their world for Jesus. We also believe that as long as churches (and parents) do only what they are doing, they will get only results they are presently getting. That’s why we needed a more cohesive plan.

The orange curriculum is a high energy, unapologetically Bible-focused, curriculum for nursery through high school. It’s engaging and multi-media and activity centered. It’s also centered around small groups which aligns very well with our church’s disciple-making vision.

Our “orange” strategy makes it very easy for us to partner with families in equipping



them with the tools they need for nurturing their child (ren)’s faith at home. Each week parents are provide with a Parent Cue Card that summarizes the Bible story, memory verse, and questions to spark a conversation about the week’s lesson. We also want to encourage kids to begin developing personal times with God, and frequently, we know this begins with parents reading with them. We send home weekly God Times Cards to provide kids and parents with four days of engaging devotions that include reading Scripture, doing a short activity to promote thought and application, and prayer.

Though this process has been a long transition with some hiccups along the way, we are very thankful for where God has taken us and we’re excited about where He’ll lead us next. If you’d like more information about Grace Church’s orange transition or the orange strategy, I’d love to talk with you.

## News from Benefits Corporation

- The deadline to distribute W-2s to employees, including pastors, is February 2, 2015 with the employer filing deadline of March 2 if filed on paper or March 31 if filed electronically. Social Security Administration's Business Services Online (BSO), [www.ssa.gov/bso](http://www.ssa.gov/bso), is an easy convenient method for producing the employee and employer copies of the W-2 on white paper, no forms, and for filing the W-2s electronically with SSA. We encourage all church treasurers that produce their W-2s in-house to use the SSA BSO services.

Reporting the cost of employer sponsored health insurance plans is not required on 2014 W-2s filed in 2015. **It has been determined that the EC Church is a small employer, thus removing the requirement to report the cost of health insurance.**

- Please remember that the EC Benefits administrative fee is due from churches on April 15, 2015, retirees are not subject to the fee.
- Please begin using the 2015 Ministry Fund forms for January offerings. Offerings collected in December 2014 should be remitted on the 2014 Ministry Fund forms.
- The 2014 Business Mileage Reimbursement increased to \$.575/mile on January 1, 2015.
- Year end giving statements to donors must include a phrase similar to or contain words "no goods or services were exchanged for these contributions." The IRS has resources available, [www.irs.gov](http://www.irs.gov), to assist with charitable contributions; Tax Guide for Churches and Religious Organizations and Publication 526 Charitable Contributions.
- It is a violation of federal law to reimburse a non-superannuated/non-retired pastor for the cost of healthcare expenses outside of the denominational benefit plans. The denomination benefit plans consist of the Highmark Health Insurance, FSA and the HRA. Any direct reimbursement by the employer to the employee for health insurance premiums, medical claims, medical supplies or equipment or prescriptions is against the law. Fines of up to \$100/day per employee are possible.

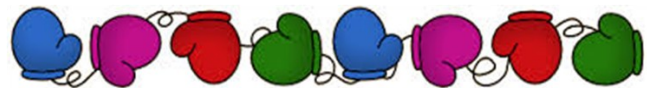
Superannuated or retired pastors receiving the

benefit of their church paying for the cost of their Highmark Freedom Blue Medicare supplemental plan was not covered in the guidance released by the IRS. We are operating under the assumption that the non-taxable reimbursement of the Highmark Freedom Blue premiums to the employee or payment to EC Benefits can continue because Medicare supplemental plans are not included in the Affordable Care Act (ACA). The guidance issued by the IRS was intended to assist employers to comply with the ACA and since Medicare supplemental plans are not included in the ACA, compliance is not possible. However, this assumption can change if additional information is released.

### Find out what a health care procedure will cost before you schedule it!

Highmark is making it easier for members to make important health care decisions by providing a means to know what a procedure will cost prior to scheduling it. It allows members to get a reliable estimate of anticipated health care costs by using its large database of procedural costs. The Care Cost Estimator then calculates the out-of-pocket expenses, based on the member's health insurance plan for deductibles and coinsurance. As of January 1, 2015, the Care Cost Estimator is now available for both our Highmark Smart Blue PPO health insurance plan and our retiree Highmark Freedom Blue Medicare Advantage plan. Highmark member participants can access the Care Cost Estimator by logging in on their Highmark website account at [www.highmark.com](http://www.highmark.com). Members can also use the Rx link on the website to get prescription drug costs, as well.

## *New Child Abuse/Criminal Check Laws*

Several new laws came into effect in Pennsylvania with the start of the new year and several more in June of 2015. They all affect how we deal with child abuse in our churches and other community organizations. Every local congregation is being impacted by these new laws if you provide any kind of children or youth ministry including nursery, Sunday school, and Vacation Bible School.



Below are bullet points that you should know. We encourage you to look for a training in your area, the discussion alone will help you think through things much more thoroughly than just reading these few points. You can even use a simple Google search for "free mandated reporter training in PA" to discover all kinds of information.

The ECC Christian Education Committee is trying to set up regional training events to be able to give you a more complete picture of how these new laws impact staff and volunteers who help in any way with children and youth ministries. Please watch for announcements to arrive via email and the EC LEADER.

### Main Themes:

- Anyone working with children is now considered a mandated reporter, not just pastors.
- Most churches most likely use a system where if abuse is suspected the teacher or nursery worker reports it to the pastor who would then call child-line. Now the volunteer will be required to call IMMEDIATELY. Failure to do so could result in misdemeanor charges against the individual.
- You now need to call if you have reasonable suspicion, you do not need to see physical signs of abuse.
- Criminal background and sexual abuse history checks are required for anyone working with children and all will need to be updated every three years. Third party groups, such as Protect my Ministry, will no longer be valid. If a volunteer has been living in Pennsylvania for less than 10 years an FBI fingerprint check will also be needed.
