recently heard of a pastor who described his congregation as being made up of "familiar strangers"; "familiar strangers" in their relationships with him and with each other. He felt that he knew who they were, but didn't really know them. I think that's a sad commentary on many of our relationships in 21st Century American life. Our interactions with people, even fellow church members, are so often limited to the superficial and trivial matters of life. In contrast, Jesus prayed that his followers would be "one"; intimately connected to him and to each other, just as Jesus is one with the Father. Later, as Luke described the early church, he wrote, "All the believers devoted themselves to the apostles' teaching, and to fellowship, and to share in meals (including the Lord's Supper), and to prayer." (Acts 2:42 NLT) That doesn't sound like a group of "familiar strangers" to me.

Following Jesus means not only

joining with him in faith but committing to each other as followers of Jesus. I think one of the keys to really knowing each other is found in the "one anothers" spread through the New Testament. The "one anothers" are not just meant for individual Christians in a local church, but are just as valid between local congregations in the one church. The Bible reminds us that even though we are different from each other, come from different regions of the country, and represent over 130 different EC congregations and ministries, as disciples of Jesus we all have the same God as Father. We are connected to each other. We drive different kinds of cars, we don't dress alike, we don't think alike, but we work at living together in harmony for the good of the family of God and his Kingdom. I am reminded of a story of a church that had to make the difficult decision about cutting down a big shade tree in the parking lot. One older man argued long that they should preserve the tree, but the

decision went the other way. On the day they cut it down he was the first one to show up. Someone said, "I thought you didn't want that tree cut down, He said, "I don't but WE decided to cut it down, so I'm here to help." That is working at being united. There's power when we work together. That is a really important piece as we move into our new denominational structure.


F. Thank God for the many faithful members of our "old" Commissions and Committees and pray for all those who are volunteering to be a part of our "new" Community structure.

Doris Seiverling, a resident at StoneRidge Town Centre* in Myerstown, doesn't like just sitting around doing nothing. Four years ago, she joined a small group of "compassionate and caring friends" who for several years have been doing various knitting and crocheting projects for newborns and for others in need. "I have to do some-



thing; I can't just sit. I like to keep myself occupied," she said. Since joining the group, her project has been the creation of knitted baby caps for newborns at Reading Hospital. And, she recently crossed a threshold which had been a personal goal she set for herself, that of creating 1000 baby hats! The hospital is so delighted to benefit from this, and the other special projects from this group of friends, that they began supplying the yarn for their work. While having just completed 1000 hats, Doris has no intention of stopping or even slowing down, but she will continue to bless others with her sewing talents. This is truly a labor of love.

Doris has been doing sewing crafts for most of her life. She learned how to sew on a peddle-driven, trendle sewing machine at ten years old while a member of 4-H. Now at 81, she tells people that she has "71 years of experience!" Later, she became a 4-H leader and even taught sewing during her time with the organization. Over the years, she made clothes for herself and her family, including shirts for her husband who passed away six years ago, and draperies, comfort tops and shawls. Her work is lovely, and she has blessed many people throughout the years with her creative gifts. News from Benefits Corporation

New Overtime Rules

You may have heard of the new overtime rules for salaried workers released in early May 2016 and go into effect on December 1, 2016. The new rules allow salaried employees earning less than \$47,476 per year to be paid overtime for hours worked over 40 yours a week. Most pastors and church workers are exempt from the new overtime rules regardless of their annual salary. There are a couple exceptions to the exemption for pastors and church workers not qualifying for overtime such as child daycare workers. If your church operates a daycare and employs a salaried manager/supervisor/director that position may qualify for overtime if their salary is less than \$47,476/yr. Another less common church employee that could qualify for overtime would be a position at your church that regularly engages in interstate commerce. Change in Pastor re: Insurance

If your church is changing pastors on July 1 please be aware that benefit payments may change, e.g. health insurance and pension. The health insurance invoice received at the church during June, due June 15, is for the month of July and should reflect any change in coverage for a new pastor. Every year there is at least one change in health insurance coverage at a church that is a surprise to us. Pastors and their families are not covered by our health insurance plan until a Capital Blue Cross application is completed, submitted and accepted for processing. Please remind a new pastor joining our health insurance plan to contact Dave King for Capital Blue Cross and Prime Pay applications. Pastors must also complete a form to cancel their health insurance. The application to join the plan and the insurance cancellation form requires the pastor's signature to be valid. A church will continue to be billed for health insurance until the cancellation form is processed.

A change in a pastoral classification from full time to part time also includes a change in the church's mandatory pension compensation. The 2016 Pastoral Compensation forms have the correct pension contributions for full time and part time pastors.

Annual Corporation Meeting

The annual EC Benefits Corporation meeting was held during the Thursday (May 26) afternoon session of the EC National Conference. Members of the National Conference are encouraged to read the EC Benefits report that was included with your National Conference reports. A motion was presented and approved to eliminate the health insurance mandate for full time assigned EC pastors effective January 1, 2017. The approved motion was as follows: To remove the health insurance mandate as referenced in the EC Benefits Corporation Bylaws Article IX Paragraph 3 section effective January 1, 2017. Newly credentialed pastors at the May 2016 National Conference are exempt from the mandate as currently in effect.

The decision to remove a pastor from the denomination sponsored health insurance plan must be mutually agreed to by both the church and the pastor. Lay church leadership cannot force a pastor into a different health insurance plan nor should a pastor be allowed to jeopardize his health or the health of his family by enrolling in a lower cost health insurance plan to benefit the church financially. A decision to leave the denominational plan may seem to be an easy financial decision to make but it is not. The Affordable Care Act did not make the health insurance marketplace less regulated. The EC Benefits Corporation will be releasing educational materials to assist pastors and churches to make a decision to leave the denominational plan. Please thoroughly study the materials released and contact Dave King or Kevin Henry with any questions or to talk through the health insurance situation before making a decision. The penalties for noncompliance can be severe.

We are ensuring that our applicants will have intentional opportunities to work with their lead pastors in some critical areas of preparation. So stay tuned. We will provide better explanations about these changes in the near future.

We are also recommending that seminary students and others, who are sensing a calling from God, to contact the Ministerial Development Associate as early as possible in the process. The PAC is a critical first step toward obtaining credentials in the EC Church. We should not confuse the role of the PAC as a gateway for the stationing process, but rather as the initial stage of the credentialing process. 

In order to accomplish these tasks, we will have to consider more seriously how to engage this process as a community. As I personally consider this newly defined role, I see the value in empowering several subgroups of leaders, who can help men and women fulfill their ministry callings—this is not a solo act. As I have enlisted people for the MDC Executive Team, I have considered those who are already qualified and experienced in the various areas critical to the community, and who will help to populate the many subgroups of MDC—see the diagram to the right.

The goal is to involve large numbers of pastors and

leaders as assessors, examiners, instructors, coaches, seminary reps, and facilitators. In so doing, candidates for ministry are guided toward the completion of their credentials in a way that helps to embed a disciplemaking DNA into each candidate's approach to ministry.

When pastors, deacons, deaconesses, and preachers are commissioned or ordained, our hope is that they will be able to stand before the members of the National Conference and state: "I am a contributor to



God's mission through the Evangelical Congregational Church, because I have felt the loving, supportive, accountable touch throughout the MDC process—shaping me into one prepared to minister with my EC brothers and sisters for God's kingdom in our generation and the ones to follow."

It is a "community thing" with a disciple-making approach! Please pray with me for the EC Church to be empowered by new leaders, who are shaped for ministry now and in the future.
