ou've no doubt received your copy of the 2015 National Conference Journal. Since that wonderful day it arrived in the mail in a beautiful new notebook or on a compact disk you've hardly been able to take your eyes off it, you've used it for your daily devotions; or maybe not!

- You may have noticed that this year's National Conference Journal has a new section, an Appendix. The Appendix contains a number of documents that I believe can be a helpful resource to local pastors and congregational leaders. Here's a brief overview:
- The Covenant—The National Conference adopted this four-point Covenant in 2014 in order to guide us in the current restructuring of our denomination.
- Enduring Covenant between the de-

nomination and Evangelical Seminar—Adopted in 2012, this document sets out in general terms the relationship between the Evangelical Congregational Church and Evangelical Seminary.

- Enduring Covenant between the denomination and New Dawn Community Services— Adopted in 2015 this document sets out in general terms the relationship between the Evangelical Congregational Church and New Dawn which operates three retirement communities.
- Leadership in The E.C. Church—The National Conference adopted this statement on denominational and congregational leadership including, but not limited to, what has traditionally been called the pastoral role.

This statement draws our attention to three core graces and five categories of leadership in the church.

- The Church—This is our statement on who we are as the church, "a people called by God to his mission..." It provides a scriptural foundation for who we are and what we do as the Evangelical Congregational denomination as well as local congregations.
- Theology of Marriage—We live in a time when terms, definitions, and traditionally accepted understanding are being challenged and redefined. This statement, adopted by National Conference in 2015, clearly presents our denomination's position on marriage based on the Word of God.

### News from Benefits Corporation

The EC Benefits Trustees have approved a switch in the active pastor's health insurance plan to Capital Blue Cross (CBC) from Highmark effective October 1, 2015. The decision was mainly driven by cost. Capital Blue Cross offered a plan with a sub 3% rate increase and Highmark offered a 16% increase over the prior year's rates. The CBC plan is almost identical to the Highmark plan. Office visit co-pays are a little higher but prescription co-pays are a little lower with the CBC plan. The CBC plan does have higher deductibles, however the annual maximum out of pocket for covered medical expenses, excluding co-pays, remains at \$500 with the HRA paying costs above \$500. The maximum out of pocket for prescriptions also remains at \$1,800 annually.

#### Two New Benefits on October 1.

- a \$1,800 cap on out of pocket costs for outpatient therapy services, physical therapy, occupational therapy, speech therapy, respiratory therapy, and manipulative therapy. The covered pastor will only incur a maximum in \$1,800 for covered outpatient therapy in either therapy visit co-pays or therapy visit costs. The HRA will reimburse the pastor for any out of pocket costs above \$1,800.
- 2) A limited dental plan has been added at no additional cost for health plan participants. The plan is the Value Plan 75. The plan will pay 75% of the cost of most dental services. The limitation of the plan is the number of participating providers. Please see https://www.capbluecross.com to confirm your dentist's participation.

If you have incurred medical expenses above \$500 or prescription costs above \$1,800 you may be eligible for reimbursement of your out of pocket costs from the HRA. The HRA plan year ended on September 30, 2015 and all requests for reimbursement for the October 2014-September 2015 plan year must be received by PrimePay, our HRA administrator, by December 29, 2015, ninety days after the end of the plan year. If you need assistance with PrimePay please contact David King or me at the EC Church Center and we will walk you through the process.

The cost to the churches is not increasing. The HRA cushion is high enough to absorb the premium cost increase and the new benefits. It is unlikely that the rates will remain unchanged in future years. The EC Benefits Trustees are very aware of the tension caused by the cost of health insurance and they are committed to serving the pastors and the local EC Church. The US health insurance market is constantly in flux. The circumstances surrounding the annual plan renewal are different every year. However, the trend to push responsibility for healthcare and lifestyle decision on the individual is continuing with your pocketbook feeling the most pain. Planning for your long term health is just as important as planning for your retirement. Accidents and illnesses are going to happen but many healthcare conditions are preventable and manageable with healthy lifestyle choices.



#### **Highmark Freedom Blue**

As approved by the members of the EC Benefits Corporation at the May 2015 EC Benefits Annual Corporation Meeting, beginning in 2016 and annually through 2019, each of the above EC Church contributions to the premium will be reduced by 20% until, in 2020, the entire contribution by the EC Church has been eliminated. The retiree is responsible for the remaining portion of the premium not paid by the EC Church. Beginning in December 2015, for the January 2016 premium, participants on the Highmark Freedom Blue plan will be receiving an invoice from Highmark for their portion of the premium. A retiree's portion of the Highmark Freedom Blue premium will be based on their Medicare eligibility date with a 20% per year increase in the amount the retiree will pay. For example, a retiree eligible for Medicare in 2006 received 75% of the Freedom Blue premium paid for by the National Conference and the retiree paid 25% of the premium. Starting with the January 2016 Freedom Blue premium retirees eligible for Medicare in 2006 will pay 25% of the premium plus 20% of the portion the denomination is paying or around 40% of the total premium. Each year the amount the denomination is paying will decrease by 20% and that portion will be transferred to the retiree until 2020 when the retiree will be responsible for the entire Freedom Blue premium.

In early November a letter will be received by each retiree explaining the change in detail.

There are many Medicare Advantage plans available even some at no cost to participants. However, each plan will have positives and negatives in terms of participating providers and benefits provided. Please thoroughly investigate any Medicare Advantage plan before switching plans. If a retiree does not have the financial means to assume a larger portion of the Freedom Blue plan the Manna Fund is available to financially assist the retiree.



#### Manna Fund

The Manna Fund was established to assist our retired clergy and surviving spouses with financial needs. The income limits to qualify for Manna Fund distribution were recently changed to 200% of the federal poverty level as defined by the US Department of Health and Human Services, the current Manna Fund income limits are \$23,540 for a single and \$31,960 for a couple. If you are aware of any of our retired clergy or surviving spouse that could benefit from a Manna Fund distribution please encourage them to complete an application for assistance. Manna Fund applications are mailed to retired clergy and surviving spouses in April and an application can also be received from the Benefits Administrator at the EC Church Center.



#### **End of Year Reporting**

We are quickly approaching the end of the calendar year and we are encouraging all the local church pastors, treasurers and administrators to begin planning for the required year end reporting. Required reporting includes year end tax forms, giving statements, denomination annual reports and pastor compensation forms. A small amount of preparation and planning early in the process will save time and frustration later. Due dates for year-end reporting:

Form 1099-MISC (independent contractors) February 1, 2016 Filed with IRS February 29, 2016 (paper forms) or March 31, 2016 (electronically)

Pastors are employees of the local church and should receive a W-2 with federal, state and local taxes withheld from every paycheck.

### CODE OF ETHICS FOR CONGREGATIONS AND THEIR LEADERSHIP

A few years ago the National Association of Evangelicals (NAE), of which the Evangelical Congregational Church is a member, published a *"Code of Ethics for Pastors"*. Our Leadership Commission distributed that document to all our pastors and leaders. At the time Leith Anderson, NAE President stated "Most pastors are highly ethical, but few have signed a written code of ethics. This is every




pastor's opportunity to know, commit and tell others about a personal and professional standard of biblical pastoral ethics." At that time our Leadership Commission encouraged pastors and local leaders to put that code of ethics on the agenda for an upcoming Board/Council/Pastoral Relations Committee meeting to discuss, adopt, and live.

Now the NAE has published a companion piece, a "*Code of Ethics for Congregations and Their Leadership*". Church boards and leadership teams face many decisions as they serve their congregations. Those choices have consequences for the health and ministry of the local church and the denomination. The National Association of Evangelicals developed the NAE Code of Ethics for Congregations and Their Leadership Teams to equip church leaders to make wise decisions.

Among the gifts Jesus provides the Church are pastors to teach congregations, lead them, and care for their spiritual well -being. In return, the lay leaders of our congregations are responsible to provide for the clergy and to facilitate their work. They also have responsibilities to the congregation at large, to the family of churches to which they belong, and to the communities in which they live and worship.

The Leadership Commission of our denomination will soon be emailing copies of the Code of Ethics for Pastors and the new Code of Ethics for Congregations and Their Leadership to all of our pastors and leaders. Please watch your "in box" for their arrival, read them and use them with our leaders in your congregation. They are good resources we all can use.
