## From the Bishop:

I recently thought about how we are almost 18 months into our new denominational structure. It's also the month we set aside extra time to focus on the need to be thankful. So let me share some of the things I'm thankful for as I look at the work of our denomination; a few quick examples of Kingdom collaboration:

- ◆ We are seeing a greater number of pastors and congregations participating in the life of their district.
- ◆ Congregations are sending work teams to other churches in their district to help with facility projects.
- ◆ Some pastors are meeting together regularly for prayer and study around the topic of church revitalization.
- ◆ The Anthracite District came together on Sunday morning for the opening of Herndon Campmeeting. I believe all of us in attendance were thrilled by almost 300 people filling the tabernacle in praise, worship, and sharing in the Lord's Supper.
- ◆ Congregations are cooperating to make a difference in their district

as they participate in "The Church Has Left the Building" projects.

- ◆ Congregations across the conference have responded with financial gifts in response to the flooding at the Riverhill EC Church, Clarion, PA, and to the Bushkill Community Church, Bushkill, PA, to move into their own facilities.
- ◆ Another person commented to me that our denomination's connec-tional polity is being applied in tangible ways: pastors are communicating more with each other and with their District Field Director, accountability is being practiced, and people are working together and helping each other.

My friends, these are all things to be celebrated and to be thankful for. And the good news is, they aren't the only good stories to be told; there are more, lots more. Praise the Lord for a growing view of Kingdom ministry within the Evangelical Congregational Church!

## CHRISTMAS GIFTS FOR MISSIONARIES:

This is the annual reminder for individuals or churches who wish to give monetary Christmas gifts to our EC missionaries. If the

missionary serves overseas, it is better to give the monetary gift through either the GMC office or the mission agency with which the missionary serves. Cashing checks overseas always costs the recipient a lot in fees, plus it may open your check to being altered and cashed for a much higher amount than you intended.

## DO NOT SEND CARDS TO THE GMC OFFICE TO BE FORWARDED TO MISSIONARIES.

If the missionary is in the USA, either permanently or on furlough, then mail the card, check and/or gift directly to them. If you need current mailing addresses, contact Pat at the GMC office for that information. Thanks!

# News from the Ministerial Development Associate

---

## PASTORAL EDUCATION

At a recent Board of Examiners meeting, Evangelical Seminary was reconfirmed as the preferred seminary for EC pastoral students. We continue to endorse the Master of Divinity program for our licensed pastoral students and the Institute for Church Leadership for our local pastoral students. Because we realize that some of our students may not be able to participate at Evangelical due to distance, we have also worked this past year to clarify what equivalency means and how one must seek to achieve it. Additionally, the Board of Examiners has developed better categorical criteria for what we require in our educational requirements.



Although we strongly desire that students receive an education within the Wesleyan-Arminian theological tradition, we also recognize that some institutions have great programs worth considering. Therefore, we are less concerned with the overall issue of theological indoctrination, per se, if the Board of Examiners can evaluate the variance of a program's theological leanings from our own framework. Our greater concern resides with the level of a program's rigorous and challenging theological treatment, especially in terms of developing a suitable hermeneutical (interpretive) method for using God's Word. We believe that weaknesses here would severely limit student pastors in their exploration and communication of the Gospel in today's challenging world. For us, deficiencies here would not help pastors to develop an appropriate posture toward our cultural settings, or effectively communicate from the Bible's compositional uniqueness. For these reasons, we endorse Evangelical Seminary and require that those seeking credentials in the EC Church strongly consider where they receive their education before enrolling elsewhere.

Therefore, we recommend that any student involved in or beginning education toward ministry contact the Ministerial Development Associate, Rev. Jeff Byerly to determine the acceptability of their educational choices and the institution(s) involved. To not do so will frustrate everyone (especially the applicant), when working toward the goal of credentialing, ordination, and itinerancy. Our hope is to provide positive correction as soon as possible and work with each student in the credentialing process.

## SPECIAL NOTE ABOUT EVANGELICAL SEMINARY

Last month, Bishop Hill sent a letter of clarification explaining the change from mandatory to voluntary offerings toward Evangelical Seminary (and other affiliates). In light of this communication, I would additionally recommend that churches consider, if possible, placing Evangelical Seminary into their church's budgets for the coming years. As your church's Ministry Funds decrease each year, please calculate the difference from this reduction, and then provide a portion of that amount as a suitable financial gift to Evangelical Seminary. If this is not possible, I certainly understand, for it *IS* a voluntary offering.

# News from the Executive Director

---

The EC Benefits Trustees have renewed the [active pastor's health insurance](#) with Capital Blue Cross (CBC) effective October 1, 2017. The rates to the local church have increased 2%, the new rates are listed on the EC Church Center website. There were no changes in benefits with the plan renewal. The annual maximum out of pocket for covered medical expenses, excluding co-pays, remains at \$500 with the HRA paying costs above \$500. The maximum out of pocket for prescriptions and outpatient therapy services (physical therapy, occupational therapy, speech therapy, respiratory therapy and manipulative therapy) also remain at \$1,800 annually.

The limited dental plan, Value Plan 75, was also renewed. The plan will pay 75% of the cost of most dental services. The limitation of the plan is the number of participating providers. Please see <https://www.capbluecross.com> to confirm your dentist's participation.

If you have incurred medical expenses above \$500 or prescription or outpatient therapy costs above \$1,800 you may be eligible for reimbursement of your out of pocket costs from the HRA. The HRA plan year ends on September 30, 2017 and all requests for reimbursement for the October 2016-September 2017 plan year must be received by PrimePay, our HRA administrator, by December 29, 2017, ninety days after the end of the plan year. If you need assistance with PrimePay please contact Dave King or me at the EC Church Center and we will walk you through the process.

The EC Benefits Trustees are very aware of the tension caused by the cost of health insurance and they are committed to serving the pastors and the local EC church. The US health insurance market is constantly in flux. The circumstances surrounding the annual plan renewal are different every year. However, the trend to push responsibility for healthcare and lifestyle decision onto the individual is continuing with your pocketbook feeling the most pain. Planning for your long term health is just as important as planning your retirement. Accidents and illnesses are going to happen but many healthcare conditions are preventable and manageable with healthy lifestyle choices.

## Highmark Freedom Blue

The retiree Medicare supplemental plan, Highmark Freedom Blue, is increasing by \$8/mon to \$224 per person per month, effective January 1, 2018, with no minor changes in coverage levels.

As approved by the members of the EC Benefits Corporation at the May 2015 EC Benefits Annual Corporation Meeting, beginning in 2016 and annually through 2019, the EC Church contribution to the cost of the Medicare Supplemental premium will be reduced by 20% until, in 2020, the entire contribution by the EC Church has been eliminated.

The retiree is responsible for the remaining portion of the premium not paid by the EC Church.

For a husband and wife on Freedom Blue double the amounts above.

The open enrollment period for the Highmark Freedom Blue plan is from October 15, 2017 through December 7, 2017. Retirees enrolled in another Medicare supplemental plan or not in any Medicare supplemental plan may join the Freedom Blue plan only during the open enrollment period. The open enrollment period does not affect pastors that plan on retiring after December 7, 2017. Medicare eligible pastors may join Freedom Blue at the time they superannuate from pastoral service.

It is very important that the retiree does not fall behind on payments to Highmark Freedom Blue. If a retiree is having difficulty paying the monthly premium the Manna Fund is available for financial assistance. Please contact David King in the EC Benefits office for a Manna Fund application.

There are many Medicare Advantage plans available even some at no cost to the participant. However, each plan will have positives and negatives in terms of participating providers and benefits provided. Please thoroughly investigate any Medicare Advantage plan before switching plans. If a retiree does not have the financial means to assume a larger portion of the Freedom Blue plan the Manna Fund is available to financially assist the retiree.

## Manna Fund

The Manna Fund was established to assist our retired clergy and surviving spouses with financial needs. The income limits to qualify for Manna Fund distribution were recently changed to 200% of the federal poverty level as defined by the US Department of Health and Human Services, the current Manna Fund income limits are \$24,120 for a single and \$32,480 for a couple. If you are aware of any of our retired clergy or surviving spouses that could benefit from a Manna Fund distribution please encourage them to complete an application for assistance. Manna Fund applications are mailed to retired clergy and surviving spouses in April and an application can also be received from the Benefits Administrator at the EC Church Center.

## Pastoral Compensation

---

Per the approved Pastoral Compensation report the annual Social Security Administration Cost of Living Adjustment (SSA COLA) will be used as the 2018 annual recommended pastoral salary increase. The Social Security Administration released their 2018 COLA increase at 2.0% (.02).

Churches unable to give at least a 2.0% salary increase must notify their District Field Director prior to any official action taken to set the pastor's salary for 2018.

Churches that are financially able are encouraged to give either a larger percentage increase or to consider an additional increase as a merit raise in salary for each pastor. This merit raise would be in addition to the approved percentage salary increase.

Most, if not all, denominations are struggling with pastor salaries. There are many reasons (controllable and uncontrollable) why this has occurred and pointing fingers and affixing blame is not the solution. The credentialed men and women of the EC Church are good people and the lay leadership in the local EC Church are men and women of integrity. Both groups are encouraged to prayerfully work

together with open honest dialogue on pastoral compensation. The answer may not be financial. Maybe the church can offer an extra week of vacation (also encourage the pastor to take the extra week of vacation) or ease the pastor's workload by the congregation assuming a time consuming duty. Be careful with cash gifts or bonuses, any cash payments to a pastor is taxable income. Please treat your pastoral staff with the appreciation and admiration they deserve.

### Clergy Housing Allowance

The clergy housing allowance is once again in the news. A federal judge in Wisconsin found the clergy housing allowance to be unconstitutional, however at this time there are no changes in the legality of the housing allowance. Churches should approve the pastoral housing allowance for 2018. An appeal will be filed with the appellate court in Chicago and most likely this case will be heard before the U.S. Supreme Court. A final decision on the clergy housing allowance is multiple years in the future. As information becomes available it will be passed along. Please ask any questions.
