From the Bishop

hoever said the summer is the "slow season" must not be involved in ministry! It took a while but I am pleased to say that I was able to meet with the members of the Covenant Implementation Team for a kick-off retreat on September 8-9. The implementation Team members are: Bishop Bruce Hill, chair, Lewie Bennett, Jeff Byerly, Chuck Campbell, John Friedlund, Kevin Henry, Gary Kuehner, Gordy Lewis, Kirk Marks, Deb Patterson, Ted Rathman, Becky Reigle and Randy Sizemore.

Our task is to discuss, plan, and discover how we can implement the changes needed to fulfill the commitments made in the Covenant adopted during National Conference. The four points of the Covenant are:

- 1. We will move to a regional shared ministry and leadership model.
- We will re-evaluate our denominational relationships with affiliate ministries.
- 3. We will substantially reduce denominational operating expenses.
- 4. We will significantly reduce ministry fund asking from local churches.

Our challenge will be how to implement those points into the life of a denomination consisting of over 60 sub-groups that are interconnected within a larger puzzle frame, (including committees, commissions, elected NC personnel, paid employees, district churches, ministry affiliates, and others). I'd like to say we're done, we have it figured out. While I can't say "we're done", I can say we're off to a good start.

I am pleased to report that as the Team met we experienced a strong conviction that the Lord would lead us in this work. There was unanimity that is rare for that type of gathering. Praise the Lord! We believe the Lord is revealing a way forward where we can reduce our denominational operating expenses and our ministry funds, while at the same time establishing a strong denominational community that can strengthen our local churches, enhance communication, and deliver vital ministry resources. We are working together to see a denomination in which local congregations can expect their relationship with the denomination to be one in which the local church enjoys enhanced opportunities to bless the world through denominational connections and receives resources. It is these connections that will enable the local church to fulfill its commission. That is our challenge, but we believe the Lord is showing us the way forward.

Please join me in praying for the Covenant Implementation Team. We have a lot of work to do. We are not equal to such a task, but we know the Lord is! May he, through his Holy Spirit, give us the wisdom and the strength to fully implement the Covenant into the life of the Evangelical Congregational Church for the glory of his eternal Kingdom.

News from Benefits Corporation

Housing Allowance

The information below is an excerpt from an email update by Art Rhoades, President and CEO of the Church of God Benefits Board, Inc.

"The Seventh Circuit Court of Appeals in Chicago heard oral argument in the housing allowance case (Freedom From Religion Foundation vs. Lew) on Tuesday, September 9, 2014. From knowledgeable court room observers, there was agreement that the arguments to maintain the ministerial housing allowance went rather well and received a fair hearing from the appellate court. The attorney for the government, speaking in support of Section 107 of the Tax Code and in favor of keeping the housing allowance, was experienced and wellprepared...

From listening to the questions posed by the three-judge panel (Judges Rovner, Flaum and Hamilton), it was clearly obvious that the judges had read the briefs, including our amicus brief, and were ready with their questions. The questions seemed to reflect the judges understanding of the magnitude of the matter before them—and the potential impact that their decision could have on ministers.

While court observers have differing opinions on how the Seventh Circuit might rule in this matter, it is expected that a decision could be handed down well before the end of 2014. With the judges expressing so much familiarity with the written arguments in the case, it is expected that they will release an opinion sooner rather than later. As soon as that opinion is released, we will ad-

vise you of such."

The overall tone of the email was positive but also cautious. The legal arguments made by the FFRF in this case were technical and hinged on a couple points of the law. I do not have enough experience with the law to clearly explain the legal arguments however, what can be gleaned was that while a positive outcome in this case will bolster support for the housing allowance, the FFRF will continue to fight this issue. There is a lot of historical legislative actions and court decision that support the legality of the housing allowance. But, there are many practical inconstancies in the application of the law resulting from how different faith groups and denominations certify ministers of the Gospel, pastors that stretch the housing allowance rules and what is the definition of a church or religious order, that will make further defense more difficult.
